Dear Applicant:

On December 28, 2009, Licensee - Valley Broadcasting Company, 1790 Vassar Street, Reno, NV. 89502, was sent a 30 day deficiency letter outlining the following problems:

Our preliminary engineering review reveals that your proposed facility does not comply with the Commission's interference rules. Specifically, the proposal is predicted to cause interference to the following facilities:

KBVH-LP BNPTTL-20000830AXM CHANNEL 23 ELY, NV

**Additionally**, this application requires tower registration. If the tower is not registered with the Federal Aviation Agency (FAA).

The licensee was given the opportunity to file a minor amendment to resolve these specified problems within (30) days from the date of this letter. Your amendment must be filed electronically. If not so amended, your application will be considered incomplete and subsequently dismissed.

Our records show that an amendment was filed on February 17, 2010 to resolve the above referenced specified problems. Our current engineering analysis shows that the interference issue has been resolved; however, the tower registration is still required.

Further review shows that you did not provide us with the necessary tower registration information requested in the above letter Imported below is a copy of our tower search results based on the coordinates and technical information provided in you proposal:
