Dear Ms. Dortch:

This is to request that the Commission update its records to reflect that the corporate name of National Farm Workers Service Center, Inc., licensee of the above-referenced noncommercial FM radio stations, was, by duly authorized corporate resolution and amendment, changed to the "Cesar Chavez Foundation." A copy of the associated Certificate of Amendment of the corporation's Articles of Incorporation, as filed with the State of California, is attached. Also attached is a copy of a letter from the Internal Revenue Service acknowledging the continuing 501(c)(3) status of the entity operating under the name Cesar Chavez Foundation, which has the same tax ID number as did the National Farm Workers Service Center, Inc.

It is noted that there is no change in the ownership structure, principals, contact persons, or official mailing address for the renamed entity, and hence no Form 316 is required to effectuate the requested change. The name has been changed in CDBS and CORES, but it is respectfully requested that the licenses for KNAI and KUFW be reissued in the name of Cesar Chavez Corporation and mailed to the address of record.


The name of this corporation is CESAR CHAVEZ FOUNDATION.


CONSENT TO USE OF NAME
