WITHDRAWAL OF INFORMAL OBJECTION

State Board of Education, State of Idaho, which operates as Idaho Public TV (“Idaho PTV”), hereby withdraws its Informal Objection, filed on July 6, 2012, with regard to the above-captioned license to cover construction permit for a digital companion channel. With respect thereto, the following is stated:

Idaho PTV submitted its Informal Objection to the above-captioned Neuhoff Family Limited Partnership (“Neuhoff”) application for license to cover the construction permit for the KTWT-LP digital companion channel facility on the basis that the facility had not been constructed entirely as authorized. Specifically, it appeared that the transmitting antenna for the station was mounted too high. In addition, Idaho PTV’s digital translator station K14IC-D, Burley, Idaho, had been suffering substantial, objectionable interference following the completion of the KTWT-LP digital facilities.

Once it became aware of Idaho PTV’s filing, however, Neuhoff took quick action to suspend operation of KTWT-LP. Idaho PTV was informed that the antenna would be removed

and reinstalled at the authorized height, and it has now been told that the reinstallation is imminent. Neuhoff also told Idaho PTV that the initial installation had been completely inadvertent, and that Neuhoff believed that crew mounting the antenna had misunderstood where the antenna was to be placed and had erroneously thought that the new digital antenna was to be mounted at the spot where the old analog antenna had been. Neuhoff has indicated a willingness for Idaho PTV to observe the reinstallation.

In light of these actions and representations, Idaho PTV hereby withdraws its Informal Objection based on improper construction since the situation has been quite promptly rectified.
