
This letter dismisses the following: (a) Thomas Jeffrey Grant's ("Thomas") November 1, 2010 Request for Order, which requests that the Commission issue an order rescinding the October 3, 2007 grants of the above-referenced FCC Form 316 applications for involuntary transfer of control from Milton Grant, Deceased, to the Milton Grant Living Trust ("Living Trust"), Jack Lewis, Business Trustee ("316 Proceeding #1"); (b) the applications filed in 316 Proceeding #1; (c) the pending FCC Form 315 transfer of control applications ("315 Proceeding"), in which Jack Lewis, as business trustee of the Living Trust, seeks to transfer Milton Grant's stock to two other Family Trusts; (d) Thomas' Informal Objection to the 315 Proceeding, filed on November 29, 2010, and (e) all related pleadings filed in these proceedings.

On April 15, 2011, Judge Mark A. Speiser, in the Circuit Court for the 17<sup>th</sup> Judicial Circuit of Broward County, Florida, Probate Division, issued an Order, declaring that the October 3, 2007 grants that transferred the Milton Grant stock to the Living Trust, Jack Lewis, Business Trustee (316 Proceeding #1) were null and void, and cancelling them effective immediately. Judge Speiser explained that the stock and control of the FCC licenses were no longer held by Milton Grant after his death, but had passed by operation of law to his Estate, with Bessemer Trust Company ("Bessemer") as the personal representative. Furthermore, the court confirmed Bessemer's authority, and directed it to move forward with the FCC to seek approval of the involuntary transfer of control of the licenses from Milton Grant, Deceased, to the Estate. Accordingly, Bessemer filed the applications in 316 Proceeding #2.

Pursuant to the Probate Court's Order, the Commission granted the applications filed in 316 Proceeding #2. Consequently, the applications filed in the Form 315 Proceeding are not grantable, because the stock of Milton Grant, Deceased, is no longer held by the Living Trust, so the Living Trust has nothing to transfer to the Family Trusts. The correct parties may re-file the appropriate applications, but the pleadings are moot because they relate to the legality of the Living Trust or the qualifications of the trustee, Jack Lewis.

**ACCORDINGLY, IT IS ORDERED**, That the Request for Order filed by Thomas Jeffrey Grant on November 1, 2010, the original FCC Form 316 involuntary transfer of control applications (BTCCT-20070717AAF-AAL), the pending FCC Form 315 transfer of control applications (BTCCDT-20091130AOI, AOP, ANZ, ANH, AOS, AMU), the Informal Objection against the pending FCC Form 315 transfer of control applications filed by Thomas Jeffrey Grant on November 29, 2010, and all related pleadings filed in these proceedings, **ARE DISMISSED**.
