Dear Ms. Dortch:

Pappas Telecasting of the Gulf Coast, L.P., licensee of commercial low power television station KVVV-LD, Houston, Texas, hereby notifies the FCC that as of April 6, 2013, the station is operating at variance from authorized parameters. Due to failure of one or more power amplifiers in the station's transmitter, the station is operating at 73 to 83% of authorized power. Efforts to repair or replace the power amplifier are ongoing.

In the event that the station will continue to operate at variance for 30 days or more, an appropriate request for Special Temporary Authority to operate at variance will be requested. Should you need additional information, kindly communicate directly with the undersigned.
