Dear Mr. Koerner:

Our records indicate that Station WUTI(AM), Utica, New York, has been silent since May 23, 2013. As you are aware, Section 312(g) of the Communications Act of 1934, as amended,¹ (the “Act”) provides that “if a broadcasting station fails to transmit broadcast signals for any consecutive 12-month period, then the station license granted for the operation of that broadcast station expires at the end of that period, notwithstanding any provision, term, or condition of the license to the contrary.”² Consequently, we find that WUTI(AM)’s license has expired as a matter of law.

Accordingly, the Commission's public and internal databases will be modified to indicate that the broadcast license (BML-20090710AUU) for the referenced station EXPIRED as a matter of law, at 12:01 a.m. on July 23, 2013, and we HEREBY DELETE the station's call sign WUTI(AM). Additionally, in light of these actions, we HEREBY DISMISS the pending application (File No. BR-20140122AAF) for renewal of the station’s now-expired license.

Finally, we note that it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower be maintained until the tower is dismantled.

Accordingly, the owner of the tower where the referenced station's transmitting antenna is located is required, pursuant to Section 303(q) of the Act,³ to maintain the tower in the manner prescribed by our rules and the terms of the cancelled license.⁴
