OPPOSITION TO PETITION TO DENY

Summary

Fusion Faith Center is the tentative winner in the MX Group 286. Fusion received 5 points over "You Matter's" 4 points. We submit that because the Commission selected Fusion's application over You Matter; You Matter has no standing to file a Petition to Deny.

You Matter, through its attorney, stated three arguments against Fusion Faith Centers application. We will answer each of them with clear understanding and show why they have absolutely no basis in facts.

Fusion has discovered that You Matter was not properly organized in the State of Oregon, as a public benefit non-profit, therefore their application submitted for the new LPFM CP should have been rejected. We'll show why in our arguments.

You Matter is also closely tied to Bob Lund, Station Manager of KRAD-LP. Fusion will show inseparable connections which may violate FCC rules.

ARGUMENTS AGAINST PETITION TO DENY

#1. You Matter states that Fusion's application is incomplete. This is not true.

The Fusion Faith Center application properly shows five principals on the board of directors and according to the Church Charter. These five persons are directed to conduct the business decisions of the Church. "You Matter" claimed that the registered 26 "voting members" were omitted from the 318 application. In reality, the only business that requires more than the five board members is in the case of Fusion Faith Center buying or selling real property. Since no real estate was in question on the FCC 318 application, Fusion Faith Center acted correctly in our FCC application by properly listing the church board members. (Exhibit 1)

#2. You Matter claims that Fusion's Application was not properly authorized.

This again is not true. Board President Steve Bingenheimer directed and duly authorized Ron Erickson to represent Fusion Faith Center in the tendering of this application. An act authorized by the Fusion Corporation President is most certainly legal and therefore the You Matter argument of improper authorization should be considered invalid.

If authorized representatives are not permitted to sign the 318 applications, then the "You Matter" application would also be rejected for this same reason, as it was signed by Robert Lund, Consultant. (Exhibit 2)

#3 You Matter claims improperly that we did not have reasonable assurance of the proposed transmitter location.

The location in question is known as All Secure Storage at 1172 Old Salem Road, Albany Oregon 97321. You Matter went so far as to contact the building manager regarding Fusion Faith Center locating a radio tower at the facility. The manager became somewhat confused because no one had mention Fusion Faith Center when Ron Erickson talked about placing a tower behind his unit which is #7. Ron has rented this space for a number of years for his company, Erickson Broadcast Sales Corporation. It was during that conversation that Ron Erickson assumed Reasonable Assurance had been conveyed for him to donate tower space to Fusion Faith Center. In fact, the manager now is willing to retract the previous statement regarding tower placement. (Exhibit 3)

A secondary location of a rooftop installation at the church was also approved by Steve Bingenheimer, Pastor & Church Board President. This location is within the 3.5 mile limitations in case our first choice of 1172 Old Salem Road #7 was not approved. Not only did we have Reasonable assurance, we had a back-up approved location. (Exhibit 4)

You Matter was created October 2nd 2013 by Bob Lund acting as Registered Agent and showing an address of 240 Second Avenue, Albany OR 97321. (Exhibit 5)

The registration clearly shows that this corporation is for <u>PUBLIC BENEFIT</u> as the type of Oregon Corporation and has <u>NO MEMBERS</u>. One person is listed as the sole person in the corporation. That person is Deborah Martin at an address of 240 Second Avenue #7, Albany Oregon 97321.

Since proper organization is required by Oregon, "You Matter" is not complying with the the requirements of **Oregon Revised Statutes 65.307** which clearly states: A board of directors must consist of one or more individuals for a mutual benefit or religious corporation and three or more individuals for a public benefit corporation. (Exhibit 6)

This number of board members oversight on the part of Bob Lund and You Matter cannot be corrected to satisfy the Oregon Corporation requirements without proper FCC authorization to change more than 50% of the board of directors. This is reason enough to dismiss the You Matter petition and application. May we suggest a closer look at all of the Lund submitted applications as they all have this same fatal flaw.

We contend that You Matter now has no standing for this Petition To Deny because their application for a new LPFM must be dismissed due to the fact that they are not a legal corporation. Furthermore, the connection between You Matter, Bob Lund and existing LPFM KRAD-LP is obvious and cannot be overlooked by the Commission. Through this argument we keep returning to one address; 240 Second Avenue, Albany Oregon 97321. This was the proposed address for KRAD-LP on the original 318 form, it is also the proposed studio location for You Matter and a business address for Bob Lund. Bob Lund is the station manager for KRAD-LP and the registered agent for You Matter. Finally on the You Matter FCC application, the only only contact email is bob@krad.fm Reference websites: www.lund.com & www.krad.fm

Fusion Faith Center respectively requests for the FCC to find in our favor.


