TO AMEND PARTIES TO ACTION AND TO FILE SUPPLEMENT**

Jerry Jones and A Renewed Mind (together, the "Petitioners"), by their attorneys, hereby jointly motion for leave to amend the prior pleadings submitted in this proceeding by Jerry Jones and Jonathan James as joint parties to substitute A Renewed Mind for Mr. James. Mr. James' interest in assignor Community Broadcast Group, Inc., has been formally assigned to A Renewed Mind, a non-profit corporation organized and existing under the laws of the State of Ohio. A Renewed Mind hereby succeeds Mr. James in interest with regard to this proceeding before the Commission and with regard to ownership interests in the licensee.

The Petitioners also seek leave to file the enclosed Supplement to Reply to Opposition to Petition to Deny the above-captioned application (the "Application"). This Supplement is necessary to provide the Commission with a copy of the Complaint filed by the Petitioners in the United States District Court for the Northern District of Ohio, Western Division, which challenges the very legality of the proposed transaction is at issue and offers further factual support for the allegations raised by the Petitioners in its prior pleadings in this matter. The Supplement is

therefore material to the Commission's consideration of whether the Application will serve the public interest.


