On behalf of Baraboo Broadcasting Corporation, this will request extension of the Special Temporary Authority (STA) to operate a Low Power Television Station on Channel 43 at Baraboo, Wisconsin.

The STA was originally granted by letter dated May 29, 1997, and was conditioned upon filing an appropriate application during the next filing window. The STA was modified and has been further extended.

The present STA (File No. BESTA-20140826ACO) expires March 18, 2015. Although a filing window for Low Power Television Stations opened in August, 2000, Baraboo Broadcasting Corporation was geographically excluded from filing an application for this facility because of the proximity to Madison, Wisconsin.
