OPPOSITION TO REQUEST OF TIME TO RESPOND

Fusion Faith Center is the properly selected Applicant as identified by the FCC selection process. Our 5 points won the CP, but for some reason YOU MATTER has failed to concede gracefully. The Commission has chosen, and there are winners and losers. Fusion Faith Center has become aware before receiving a mailing, that Dan Alpert, an Attorney for YOU MATTER has requested an extension of time to prepare a response to our opposition statements. YOU MATTER's opinions at this point should have no weight or standing. This is a purposeful delay tactic to prevent or delay granting a CP to FUSION FAITH CENTER.

WHEREAS: Fusion respectfully requests the FCC to dismiss the YOU MATTER application and without further delay issue a Construction Permit.

As we pointed out in our Opposition to the Petition To Deny, Filed against FUSION By YOU MATTER, They appear to not be a legal Oregon Corporation as they are in violation of ORS 65.307. They cannot fix this without changing over 50% of the listed Board members. In our opinion the YOU MATTER application should be dismissed immediately, thereby creating a Singleton which can be granted immediately.

Furthermore FUSION has written a letter to the Oregon Department Of Justice seeking to have the DOJ investigate the numerous and apparent shell corporations formed by Mr. Bob Lund which we believe may have been formed for the sole purpose of filing multiple LPFM applications.

Dear Mr. Harvey;

"You Matter" was created October 2nd 2013 by Bob Lund acting as Registered Agent, showing an address of 240 Second Avenue, Albany OR 97321, File #968442-96. The registration clearly shows that this corporation is for <u>PUBLIC BENEFIT</u> as the type of Oregon Corporation and has <u>NO MEMBERS</u>. One person is listed as the sole person in the corporation. That person is Deborah Martin also at an address of 240 Second Avenue #7, Albany Oregon 97321. 240 2nd Avenue is a business for profit location for Bob Lund. Page two lists the other non-profit corporations we found also filed by Mr. Lund.

Since proper organization is required by Oregon, "You Matter" is not complying with the the requirements of Oregon Revised Statutes 65.307 which clearly states: A board of directors must consist of one or more individuals for a mutual benefit or religious corporation and three or more individuals for a public benefit corporation.

We believe that Mr. Lund is really behind control of "You Matter" and several other "dummy" corporations all created in this same manner and all for the purpose of creating FCC applications for new LPFM Radio Stations. The FCC has rules pertaining to hidden attributable interest which seems to be violated by these applications. A listing of Lund filed FCC application is on the second page.

You Matter has hired an attorney, Dan J. Alpert in VA to represent them in filing the original FCC 318 forms, applications for new LPFM Stations and continues to represent You Matter in filing Petitions to Deny and other hindering communications with the FCC. It is my belief that Mr. Alpert is really representing Mr. Lund, whom we believe is paying the attorney fees. This, if true would also point to the fact that the non-profit filings of You Matter and others by Mr. Lund are corporate fronts created by Mr. Lund to "pull a fast one" on the Federal Communication Commission and The State Of Oregon.

Is it common for a Registered Agent to pay for an Attorney for the corporation when he is not a board member?

If the ORS Statute mentioned prohibits an improperly organized corporation from doing business, then all of the FCC applications Mr. Lund submitted should be dismissed and after investigating this blatant violation of Oregon Law, we ask the Oregon DOJ to contact the FCC regarding the dismissal of all of Mr. Lunds FCC Form 318 Applications.

I request an investigation into these activities and that the Oregon DOJ contact Federal authorities concerning these filings. Mr. Lund also operates currently KRAD-LP radio station in Albany OR. This was a result of the first FCC LPFM filing window and is under the Oregon non-profit umbrella of Transformation International. This, we think, is why Mr. Lund created other corporate names, so he could ultimately build and operate a small network of LPFM stations, which would be against FCC rules.

I request a follow up response from your department indicating if you will be acting upon this complaint.

In the spirit of full disclosure, Fusion Faith Center was selected by the FCC over You Matter in the application for a new LPFM station in Albany Oregon. You Matter through Dan J. Alpert, Attorney, filed a Petition to Deny our application with the FCC.

We intend to file a copy of this letter with the FCC pertaining to our application, subsequent Petition to Deny, Our Opposition To The Petition to Deny and Attorney Alperts' request for an extension to reply.

It is our understanding that an improperly organized non-profit corporation in Oregon is not authorized to conduct business, make applications or other endeavors so long as the corporate structure as related to ORS 65.307 is not compliant.
