Dear Michael:

I am writing on behalf of my client, **Bethany Church** ("Bethany"), which is the licensee of **WLFT-CD** (the "Station"), Baton Rouge, Louisiana, assigned Fac. ID No. 8653. Bethany changed its corporate name earlier this year from **Bethany World Prayer Center, Inc.**, which is the name currently listed on the Station's FCC license. Enclosed with this letter is a copy of an Extract of Minutes by which the name change was approved by the licensee's Board of Trustees. An appropriate filing was made thereafter with the Louisiana Secretary of State to complete the name change.

Bethany requests FCC staff to change the name of the licensee as listed in the Commission's official records from Bethany World Prayer Center, Inc. to its current legal name of Bethany Church and to reissue the Station's license in the name of Bethany Church. Erica Porter informed me today that she has discussed this matter with you and that you directed her to have me send these requests by letter to you, which I am doing by this means.

BE IT RESOLVED that the name of the Corporation be and is hereby changed to Bethany Church.


