**MODIFIED TIMESHARE AGREEMENT**

**The Neighborhood Center (FCC File No. BNPL 20131115AHG) and The Appalachian Community Fund (FCC File No. BNPL 20131113AFH) do hereby absorb the time for United Mountain Defense (FCC File No. BNPL 20131112BGO) upon its request for dissolving its participation in the timeshare hereby submit to the following updated timeshare agreement:**

**1. Hours of Operation.**

**Sunday:** From 12 am-12am The Neighborhood Center (**24 hours**)

**Monday:**From 12 am- 12 am The Neighborhood Center (**24 hours**)

**Tuesday:**From 12 am- 12 am The Neighborhood Center (**24 hours**)

**Wednesday:**From 5 pm-9am The Neighborhood Center (**16 hours**) and from 9am-5pm The Appalachian Community Fund (**8 hours**)

**Thursday:**From 1pm-1am The Neighborhood Center (**12 hours**), 1 am-5am The Appalachian Community Fund (**4 hours**) then from 5am-9am The Neighborhood Center (**4 hours**), and from 9am-1pm The Appalachian Community Fund (**4 hours**)

**Friday:**From 12am-12am the Neighborhood Center = **24 hours**

**Saturday:** From 12am-12am The Neighborhood Center =**24 hours**

- 1. Operating Schedule Minimum Requirements.** The hours of operation in this Agreement comply with Section 73.872(c) of the Commission's Rules by allowing each Applicant the following number of operating hours per week:

**The Neighborhood Center: 152 hours per week**


**The Appalachian Community Fund: 16 hours per week**

The hours of operation proposed in this agreement also comply with 47 C.F.R. § 73.850(b) because the LPFM station will operate at least **50** hours per week, consisting of at least **5** hours of operation per day on at least **6** days of the week.

**1. Schedule Modifications.** This Agreement may be amended or modified only by a written instrument executed by all of the Applicants and submitted to the Commission prior to the time of the proposed change.
