Dear Applicant:

Pursuant to 47 C.F.R. Section 1.1910, the Commission examines applications to determine if the applicant is delinquent in any non-tax debt owed to the Commission.<sup>1</sup> On July 1, 2015, the applicant was notified that it was delinquent on the payment of debts owed to the Federal Communications Commission.<sup>2</sup> The *Red Light Letter* indicated that if full payment or satisfactory arrangement to pay the delinquent debt was not made within 30 days of the date of the letter, the application or other request for benefit would be dismissed. The staff received no response to the *Red Light Letter*.

On January 25, 2017, the staff again notified the applicant of its debt delinquency by email, but received no response.

The Commission has not received payment of the debts identified in the *Red Light Letter*, nor have satisfactory payment arrangements been made. Accordingly, pursuant to 47 C.F.R. Sections 1.1910(b)(3) and 0.283, Application File No. BR-20140222ABL IS HEREBY DISMISSED. Additionally, in light of the dismissal of the subject license renewal application, all authority to operate station WIRD(AM), Lake Placid, New York, IS TERMINATED, the license (File No. BL-10063), most recently renewed by Application File No. BR-20060201AXO, IS HEREBY CANCELLED, and the call letters WIRD(AM) ARE DELETED. Any operation of this facility is now unauthorized and must cease immediately.



Finally, it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower be maintained until the tower is dismantled. Accordingly, the owner of the tower where the referenced station's transmitting antenna is located must maintain the tower in the manner prescribed by the Commission's rules and the terms of the expired license.<sup>3</sup>
