STANDARD BROADCAST STATION LICENSE

Subject to the provisions of the Communications Act of 1934, subsequent Acts, and Treaties, and Commission Rules made thereunder, and further subject to conditions set forth in this license, the LICENSEE

WYVE RADIO, INCORPORATED

is hereby authorized to use and operate the radio transmitting apparatus hereinafter described for the purpose of broadcasting for the term ending 3 a.m. Local Time October 1, 1981

The licensee shall use and operate said apparatus only in accordance with the following terms:

- On a frequency of 1280 kHz.
- With nominal power of - watts nighttime and 2.5 kilo watts daytime,  
with antenna input power of - watts - directional [ - current - amperes  
antenna nighttime ..... [ - resistance - ohms,  
and antenna input power of 2.5 kilo watts non directional [ antenna current 6.17 amperes  
antenna daytime ..... [ antenna resistance 65.5 ohms

Nov. 7:00am to 5:15pm; Dec. 7:30am to 5:15pm;  
Eastern Standard Time (non-advanced)
- With the station located at: Wytheville, Virginia
- With the main studio located at: 195 South First Street, Wytheville, Virginia
- Remote control point: 195 South First Street, Wytheville, Virginia
- Transmitter location: On Hwy. 603 "Cove Road", 1 mile north of Wytheville, Virginia  
ANTENNA: 200' (207' overall height) uniform, cross section, guyed, series excited radiator. Ground system consists of 120 equally spaced, buried, radials 228' in length except where limited by property line at the south, plus 120 interspaced radials 50' in length. Wire fence along south property boundary grounded by 4' iron stakes every 10'. Estimated radiation 192 mV/m/kW.

This license is issued on the licensee's representation that the statements contained in licensee's application are true and that the undertakings therein contained so far as they are consistent herewith, will be carried out in good faith. The licensee shall, during the term of this license, render such broadcasting service as will serve public interest, convenience, or necessity to the full extent of the privileges herein conferred.

This license shall not vest in the licensee any right to operate the station nor any right in the use of the frequency designated in the license beyond the term hereof, nor in any other manner than authorized herein. Neither the license nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This license is subject to the right of use or control by the Government of the United States conferred by Section 606 of the Communications Act of 1934.
