On July 5, 2018, the Satellite Division granted, with conditions, special temporary authority for a period of 180 days to Intelsat License LLC to continue to: (1) provide fixed-satellite service via Intelsat 16 at the 76.2° W.L. orbital location in the 11.7-12.2 GHz (space-to-Earth) and 14.0-14.5 GHz (Earth-to-space) frequency bands; and (2) conduct telemetry, tracking, and command operations in connection with maintaining the Intelsat 16 space station at the 76.2° W.L. orbital location using the following center frequencies: 13.9975 GHz and 14.4995 GHz (Earth-to-space); 12.19825 GHz and 12.19875 GHz (space-to-Earth).
