ViaSat, Inc. requests modification of its fixed earth station in Memphis, TN to relocate the earth station 150 feet from its currently authorized location. This earth station is currently authorized to operate in the following frequency bands: (i) 18.3-18.8 GHz, 19.7-20.2 GHz, 28.35-28.6 GHz and 29.5-30.0 GHz on a primary basis; (ii) 18.8-19.3 GHz and 28.6-29.1 GHz on a secondary basis to NGSO FSS systems; (iii) 17.8-18.3 GHz on a secondary basis to fixed terrestrial services; (iv) 27.5-28.35 GHz frequencies on a secondary basis to Upper Microwave Flexible Use Services (UMFUS) services with the rights and protections afforded by Section 25.136; and (v) 17.7-17.8 GHz on an unprotected, non-interference basis pursuant to a waiver. A technical analysis has been provided for the 27.5-28.35 GHz frequency band, in accordance with 47 CFR §25.136.
