This Application reflects a streamlining of the ownership structure of the stations licensed to Gray Television Licensee, Inc. Gray MidAmerica Television will merge with WVLT-TV, Inc. WVLT-TV, Inc. is and will remain a wholly owned subsidiary of Gray Television, Inc. WVLT-TV, Inc. will be the surviving corporation which will then own 100% of the stock of Gray Television Group, Inc. Gray Television Group, Inc. will continue to own 100% of Gray Television Licensee, Inc. Gray Television, Inc. remains the ultimate parent corporate of the licensee. Hence the transfer of control is strictly pro forma.
