Application for Authority

Class of Station: Earth Stations on-board Vessels/VSAT

Nature of Service: Earth Stations on-board Vessels, Vehicle Mounted Earth Station

Applicant seeks a blanket license for 11,000 "KyWay 1" earth stations, operating as Earth Station on Vessel (ESV), Vehicle-Mounted Earth Station (VMES) earth stations and fixed earth stations operating with the Permitted List satellites in the 14.0-14.5 GHz (Earth-to-space) and 10.95-11.2 GHz, 11.45-11.7 GHz and 11.7-12.2 GHz (space-to-Earth) frequency bands. This application was amended by IBFS File Nos. SES-AMD-20170330-00345 and SES-AMD-20170614-00647. The KyWay-1 antenna is a flat panel antenna that uses software and metamaterial technology to electronically and dynamically steer an antenna beam from a thin film transistor (TFT) panel to a target satellite.

SES-AMD-20170330-00345: (1) Added the receive frequency bands for these terminals. (2) Provided a clarification that Kymeta seeks a waiver of Section 25.222(a)(7) that requires, "control [of] all ESVs by a Hub earth station located in the United States, except that an ESV on U.S.-registered vessels may operate under control of a Hub earth station location outside the United States provided the ESV operator maintains a point of contact within the United States that will have the capability and authority to cause an ESV on a U.S.-registered vessel to cease transmitting if necessary." Kymeta indicates that operations of ESV earth stations with satellites not visible by points in the United States would not allow a U.S. HUB earth station to control the terminal. Kymeta states that its Network Operations Center (NOC) in the United States in Redmond, WA, "...will have the capability and authority to cause an ESV on any vessel, regardless of the flag country, to cease transmitting if necessary." (3) Clarified the off axis angles identified by Kymeta in Attachment 1 to Exhibit B.

SES-AMD-20170614-00647: (1) provided analysis of independent laboratory testing results in support of the RF Safety Analysis for the KyWay 1 earth stations; (2) added 5000 fixed earth stations, (3) reduced the Total EIRP for all carriers from 47 dBW to 43 dBW and (4) added the value 8W for the Total Input Power at the antenna flange.
